Procurement from entities owned by SCs/STs

3063. SHRI K. K. RAGESH:

Will the Minister of HEAVY INDUSTRIES AND PUBLIC ENTERPRISES be pleased to state:

- (a) whether the mandatory norm of four per cent of the total procurement from the entities owned by SCs/STs is followed by the Central Public Sector Enterprises (CPSEs) as stipulated by Public Procurement Policy, 2012;
- (b) if so, the details of PSUs following the norm;
- (c) the total value of procurement by PSUs during the last three years; and
- (d) the details of PSUs which are not following the norm and reasons therefor?

ANSWER

(a) to (b): The Public Procurement Policy 2012 stipulates mandatory procurement by Central Ministries/Departments/Public Sector Enterprises (CPSEs) of minimum of 20% of their total annual purchases of products produced and services rendered by Micro and Small Enterprises (MSEs) with effect from 1st April 2015. Out of this 20% target, a sub-target of 4% has been earmarked for procurement from MSEs owned by Scheduled Caste (SC)/Scheduled Tribe (ST) entrepreneurs. It is further provided in the said policy that in the event of failure of such SC/ST entrepreneurs owned MSEs to participate in tender process or meet tender requirements and L1 price, the 4% sub-target for procurement earmarked for MSEs owned by SC/ST entrepreneurs can be met from other MSEs. As per the available information, 144 CPSEs are following the above policy to the extent possible.

(c) & (d): Details of procurement by CPSEs from Micro and Small Enterprises in the last three years are as under:-

CPSEs are trying their level best to meet the targeted procurement of 4% from SC/ST entrepreneurs but finding it difficult to achieve due to several factors such as less participation of MSEs owned by SC/ST entrepreneurs in the procurement process. There are not many SC/ST entrepreneurs who can supply the intended goods/components/services required. Also, MSEs are not disclosing as to whether it is owned by SC/ST entrepreneurs(s). Absence of reliable database which can authenticate the status of MSEs being owned by SC/ST entrepreneurs etc also create additional hurdles.
