Dear Sir,

With reference to D.O. letter No.502/1/2/2014-CA-V dated 5<sup>th</sup> August, 2014 of Cabinet Secretary, the following significant activities in the Ministry of Heavy Industries (MHI) for the month of July, 2022 are highlighted:

1. On the concluding day (30<sup>th</sup> July 2022) of the 'Bijli Mahotsav' celebrations, titled 'Ujjwal Bharat Ujjwal Bhavishya Power @2047', Hon'ble Prime Minister of India, Shri Narendra Modi dedicated 100-MW floating solar project executed by BHEL at Ramagundam, Telangana to the Nation.
2. Hon'ble Minister of Heavy Industries had a review meeting on 21<sup>st</sup> July 2022 regarding ongoing power projects being implemented by BHEL.
3. Programme Agreement was signed with 3 (three) firms namely Reliance New Energy Limited, Ola Electric Mobility Private Limited and Rajesh Exports Limited on 28<sup>th</sup> July, 2022 for setting up Advanced Chemistry Cell (ACC) manufacturing facilities, under PLI for ACC.
4. I chaired a meeting of the 'Inter-Ministerial Apex Committee for the Capital Goods Scheme' on 1<sup>st</sup> July, 2022 to consider the new project proposals recommended by the Screening Committee under the Phase 2 of the 'Scheme for Enhancement of Competitiveness in the Indian Capital Goods Sector'. A total of 13 projects were sanctioned by the Apex Committee with the total project cost of Rs.321.10 crore.
5. PLI Scheme for Automobile & Auto Components:
  - (i) All Performance Bank Guarantees (PBGs) received from 85 participating companies have been verified from respective banks in July 2022.
  - (ii) I chaired the stakeholder consultation meeting for development of Advanced Automotive Technology (AAT) Portal with inter disciplinary team of Tata Motors on 7<sup>th</sup> July, 2022. This interaction will help in development of AAT portal for PLI (Auto) scheme to transfer system generated critical data regarding domestic value addition to PLI(Auto) Portal.
6. Under FAME-II, grant amounting Rs.39.03 crore was released to City/State Transport undertakings as under:
  - a. 1<sup>st</sup> tranche of grant amounting to Rs. 8.43 crore was released for deployment of 100 Electric buses in Rajkot.

- b. 2<sup>nd</sup> tranche of grant amounting to Rs. 1.8 crore was released for deployment of 10 Electric buses in Dehradun.
- c. 3<sup>rd</sup> tranche of grant amounting to Rs. 1.8 crore was released after successful operation for 06 months of 10 Electric buses in Dehradun.
- d. 3<sup>rd</sup> tranche of grant amounting to Rs. 27 crore was released after successful operation for 06 months of 150 Electric buses in Ahmedabad.

7. Issue of GST Concession Certificate is one of the important services provided by MHI under its Citizen's Charter. In July 2022, a total of 252 GST Concession Certificates have been issued.

8. BHEL booked first ever order for design, development & supply of 30Ah Li-ion Battery for Advanced Medium Combat Aircraft (AMCA) from Aeronautical Development Agency (ADA) Bangalore. BHEL will be the sole Indian supplier of Li-ion batteries for next generation aircraft and one amongst the very few manufacturers worldwide.

9. Upgraded version of CPGRAMS i.e. CPGRAMS 7.0 in respect of MHI was made live for the citizens of India after due categorization and mapping of public grievances in collaboration of QCI and DARPG.
